



CONDITIONS OF PARTICIPATION

1. Registration and participation conditions

On receipt of your complete written application you will be sent an invoice that also serves as a confirmation of registration.

A processing fee of 10.00 euros is due for invoice changes that have to be made due to missing or incorrect information provided by the participant and for which TUTECH bears no responsibility. Registration is binding.

A contract regarding attendance at the event or seminar comes into effect as soon as you receive confirmation of registration. If the event is oversubscribed, you will be informed without delay; in this case, no contract comes into effect.

Image recording, photography, film, audio or other recording of the content of an event and storage on electronic and digital media, etc. by participants is only permitted by prior written agreement on the part of the organiser. Third-party rights, in particular those concerning property, ancillary copyright and copyright, must be respected.

The general terms and conditions of Tutech Innovation GmbH apply.

2. Cancellation policy

You may cancel your registration and withdraw from the contract on payment of a handling fee of 50 euros (+ VAT) up to two weeks before the date of the event (not applicable to events for

which there is no charge). Cancellations must be made in writing. For the deadline to be met, the cancellation must have been received by Tutech Innovation GmbH by post, by fax or by email.

In the case of later cancellations received up to a week before the date of the event, half of the participation fee will be charged; after this the full fee will be charged. An exception will be made if a substitute participant is sent.

Rescheduling will be treated as cancellation.

The consumer does not have a right of cancellation pursuant to Article 312g, para. 2, clause 9 of the German Civil Code [BGB § 312g Abs. 2 Nr. 9].

2.1 Cancellation by Tutech Innovation GmbH

If the event is cancelled by the organiser due to force majeure, or for organisational or other reasons, the fee paid will be fully refunded. All other claims are excluded.

3. Data

It is necessary for us to store your personal data for the purposes of running events/seminars and invoicing you for them. The legal basis for this is Article 6, para 1, subsection b of the GDPR. We will also inform you in future about our events if you have given your permission for this. 4. Photography

The organiser reserves the right to take photographs during the event/seminar for marketing purposes. By participating in an

event/seminar you agree, if photographs are taken during the event and you are recognisable on them, to the use (free of charge) of photographic images of yourself for the purposes of marketing comparable events by Tutech Innovation GmbH, especially through print advertising, the Internet, social media, other printed media and press articles. Use of the photographs for other purposes than the aforementioned or putting the photographs into circulation through their surrender to third parties is prohibited. You agree to the publication by Tutech Innovation GmbH of the photographs for the aforementioned purposes. You agree in particular to the posting of the photographs on Tutech Innovation GmbH's website and on social media.

You also agree to the photographs being saved in digital form and processed in future by Tutech Innovation GmbH for the aforementioned purposes. You can object to the possible use for marketing purposes of photographs of you at any time, in accordance with GDPR, by sending an informal message to datenschutz@tutech.de. If you retract your permission for storage and use of the photographs, Tutech Innovation GmbH will no longer use the photographs in question for marketing purposes. The photographs in question will be deleted provided that you are personally identifiable in them.

5. Lists of participants

The organiser reserves the right to produce lists of seminar participants and to release these to the participants. You give your agreement for the list of participants containing the information provided by you (name, company) to be given to the other

participants in the event for the purpose of facilitating mutual contact. You may object to the use of your data for this purpose up to one day before the seminar begins by sending an informal message to datenschutz@tutech.de.

6. Liability

The organiser shall be liable for damages within statutory requirements subject to the conditions and limitations stated below.

The organiser shall be liable for damages arising from loss of life, physical injury and injury to health, moreover for damages due to wilful intent or gross negligence on the part of the organiser or his legal representative or agent acting on his behalf, moreover for damages resulting from non-compliance with a guarantee given by the organiser or due to malicious non-disclosure of defects.

The organiser shall bear limited liability for replacement in the case of damages foreseeable and typical for such a contract arising from a breach due to ordinary negligence of essential contractual obligations either by him, his legal representative or agent acting on his behalf. Essential contractual obligations are those whose fulfilment is essential to the proper implementation of the contract and on whose observation the contractual partner may regularly depend. Other claims for damages on the part of the participant are excluded. The provisions of the German Product Liability Act (Produkthaftungsgesetz) are unaffected.

The restrictions to the foregoing provisions also apply in favour of the organiser's legal representative or agent acting on his behalf in the event that claims are made against them directly.

All documentation for our events is subject to copyright. Rights to use can be transferred only by means of express granting in writing of usage rights. You are not authorised to copy licence material handed out for training and information purposes.
